In its 2014 decision of *Brinker v. Superior Court*, the California Supreme Court explained that employees must be "relieved of all duties" during their statutorily required 30-minute meal periods. Since that time, however, courts have struggled to define the exact status that employees are entitled to enjoy during the shorter 10-minute rest breaks which are also required by statute.
